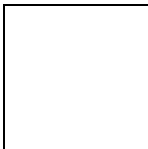

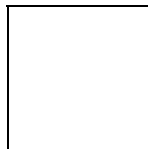

ESTABLISHMENT OF RESIDENCY ELIGIBILITY

SCHOOL YEAR \_\_\_\_\_

State Law provides that a child's residence for school purposes is the school district in which the parent or legal guardian, or legal custodian (legal guardian or custodian must be verified by court documents) holds legal residence.

CONDITION No. 1: Affiant must be of legal age and must reside within the boundaries of Guthrie Public School District. Please Note: Documented "Proof of Residence" will be required

CONDITION No. 2: The enrollment of any student admitted by Affidavit is subject to review and immediate cancellation if conditions under which the signing was permitted do not remain constant.

CONDITION No. 3: Any student enrolled by means of signed Affidavit must abide by all requirements as set forth in school policies with particular attention being given to items of regular attendance: timely academic progress in credits/grade; and acceptable citizenship, behavior, and discipline responsibilities.

CONDITION No. 4: The school district may periodically require renewal of Affidavit. If the stated facts of an Affidavit later appear to be questionable, the Administration will render an official ruling concerning the student's entitlement to receive schooling services from Guthrie Public Schools. While this process is in effect, the student's enrollment may be subjected to a temporary suspension from class attendance. Based upon the facts of the ruling, the student's enrollment with Guthrie Public Schools will then be either reinstated, or he/she will be officially withdrawn from school.

CONDITION No. 5: When an official withdrawal becomes necessary, the student will be ineligible to re-enroll unless/until a legal residence is fully established within the territorial limits of Guthrie Public Schools. Documentation, in full, will be required in such cases.

CONDITION No. 6: Misrepresentation of Facts in any Affidavit is considered to be Criminal Intent to defraud and shall be prosecuted fully as permitted by State Statutes. Violators face misdemeanor charges punishable by imprisonment not to exceed one (1) year or a fine not to exceed five hundred dollars (\$500.00) or both such fine and imprisonment. 70 OK Stat §70-1-J J(A)
